#### 1. Purpose

This policy sets out the principles by which students may request a review of any academic decision or the interpretation and application of any academic regulation of Moore College. The right of a student to request an academic appeal is mandated in legislation such as that noted in section 6 of this policy.

# 2. BACKGROUND

This revision of the policy has considered recent legislation such as the Higher Education Standards Framework (Threshold Standards) 2015 and other government requirements including Admissions Transparency.

# 3. SCOPE

This policy applies to all students, applicants or prospective students of the College. The policy applies to all academic matters of the College affecting any student enrolled or seeking enrolment in any course or unit of study of the College.

# 4. DEFINITIONS

This section sets out definitions for key terms and acronyms referred to in the Policy.

Term	Definition	
Advanced standing	A form of credit for any previous learning.	
Applicant	An applicant is a person who has already lodged an application to study a specific course.	
Course	A program of learning comprising one or more units of study, or structured workplace learning that leads to the award of a qualification. (AQF, 98)	
Final grade	The letter grade that is given to indicate the level of academic performance in a unit	

Final mark	The aggregate of marks for all assessment items that contribute to the final result of a unit		
Grade	The letter grade that is given to indicate the level of academic performance in an assessment item		
International student	An international student is means a person (whether within or outside Australia) who holds a student visa. <sup>1</sup> An international student is also known as an overseas student.		
Mark	The numerical mark given for the outcome of an assessment item		
Prospective student	A prospective student is a person who is thinking about lodging an application to study a particular course but has not yet done so.		
Research Higher Degree (RHD) Program	A postgraduate program for which the main component is an independent research thesis (as defined under levels 9 and 10 of the AQF).		
Student	Student is anyone studying at any level and by any mode at Moore College.		
Unit	A separate subject and a combination of units makes up a course of study.		

# 5. POLICY STATEMENT

# 5.1. Academic Appeal

An academic appeal may arise from any academic decision or the interpretation or application of any published academic regulation of the College.

# 5.2. Procedural Fairness

All staff involved in resolving an academic appeal by a student have a duty to observe the principles of procedural fairness, which include the following elements:

- (i) the right of the student to a fair hearing and the right of all parties involved to be heard;
- (ii) the right not to be discriminated against because of the appeal;
- (iii) if an appeal or grievance escalates, it cannot be dealt with by any person previously involved with the grievance or appeal;
- (iv) the right of the student to be accompanied by a support person, provided that person is not a practising solicitor or barrister;
- (v) all parties must have full knowledge of the nature and substance of the appeal;
- (vi) the right to an independent decision maker; and
- (vii) the decision is based solely on the relevant evidence with all submissions considered.

#### 5.3. Fees

There shall be no fees for academic appeals.

# 5.4. Appeal Resolution

- (i) The College shall provide four escalating levels for the resolution of academic appeals or grievances:
  - the responsible academic committee, which will be one of the Learning and Teaching Committee, the Research and Centres Committee or the Moore College Distance Education Committee;
  - the Principal;
  - · the Academic Board; and
  - the External Review Officer.
- (ii) International students may appeal to the External Review Officer or the Overseas Students Ombudsman.

# 5.5. Reporting

All reviews and their outcomes undertaken by the External Review Officer under this policy are reported annually to the Academic Board of the College.

Additional information necessary for carrying out or complying with this Policy is detailed in a separate Procedure.
